- Must be in final semester and within 12 hours of completing bachelor's degree requirements
- Maximum of nine (9) graduate credit hours of enrollment allowed
- Sum of undergraduate and graduate credit hours during semester of enrollment must not exceed 13 hours at BOTH institutions

A request for exception to the above criteria must include justification and be approved by the MSU Provost
